- 3. Appoint Temporary Chair Louise Worm was appointed temporary chair by chair Sara Hildebrandt.
- 4. Secretary's Report The minutes of the 2/24/2021 meeting were approved as read.

5. Unfinished Business -

6. New Business

A. 2021 NSS Fleece Sale

- Zane Van Horsen presented information about how she might establish a fleece sale, with Laura's and Sara's help, at the NSS. The major highlights of her presentation were
 social media, especially Facebook Events, would figure prominently in the sale's promotion, 2) tags describing the fleece's characteristics would accompany each fleece and 3) a ten percent NSS commission and 1 percent Ohio association commission would be charged.
- 2) Charles moved that the Promotion and Membership committee sponsor the 2021 National Show and Sale Fleece Sale following Zane's recommendations with Laura handling all the details. Any recommendations from the committee should be to them by May 22. The motion was seconded by Sara. Discussion highlights 1) Charlie said that micron equipment will be on site, 2) No fleece entries fees will be charged,
- 3) Charlie suggested he possibly could take any fleeces, that rides could not be found for from the sale, back to the office and mail to the buyer as long as the fleece was prepackaged, and 4) Sara, Laura and Zane would write up a plan, due by May 22, to be passed onto the NSS committee and David. The motion passed.
- **B.** Press Releases for the NSS Sara moved that we send the CSBA press release (see below) to the addresses presented by Danny Westlake and Mike Copeland and the CSBA pay the postage. Laura seconded and the motion passed.
- **C. Blanket Giveaway in January** It was reported that 67 memberships were paid in January because of the giveaway. Five of these were new senior memberships. Charles moved we have a membership giveaway for our January 2022 membership drive Sara seconded and the motion passed.
- **D.** Web Sponsor Program and Ads Laura and Sara's hard work in putting together ads was recognized. Charles noted that he has sent out 10 catalogs to brand new potential customers in the last week, all from the jot form on the website.
- **E. SOC** Louise noted the committee should think about ads and feature articles for the next issue of the SOC. Louise completed 92 different pieces for this issue, and everything was into Ringside by the deadline.
